1	The offeror must be income Tax and Sales Tax registered and must be on active tax payer list of FBR.		
2	Should have a minimum of Three (3) years of post-registration experience in supplies of similar assignment and		
	should have completed at least 5 assignment of similar nature.		
3	Offeror must provide the quality assurance certificate, and performance satisfactory certificates.		
4	Used, refurbished, below specification, late, conditional, incomplete and optional quotations will not be acceptable.		
5	Equipment's must be delivered and installed within 30 days of issuance of Purchase Order/Notification of Award.		
6	Bid validity must be 60 days. Quotation must be signed and stamped. Price Shall be fixed and bid price should be in Pak Rupees.		
7	Non-compliance of the criteria will result in rejection of the quotation.		
8	The offeror are requested to give their best and final prices including all applicable taxes as no negotiations will be allowed at later stage.
