The Following is the qualification criteria/ terms and conditions:

The offeror must be an agent/dealer or reseller of required item in Pakistan, with a minimum of Three (3) years of experience in supplies.

Supplier/dealer should have a documented track of completing at least three (3) similar assignments, involving the supply of a comparable scale.

The offeror must be income Tax and Sales Tax registered and must be on active taxpayer list of FBR prior to issuance of purchase order.

Quotation must be typewritten.

Equipments must be delivered in Peshawar at the venue mentioned below within 30 days of issuance of Purchase Order/Notification of Award.

Prices shall be fixed and bid price should be in Pak Rupees.

Project Director is the competent authority for grievance redressal.

Non-compliance of the criteria will result in rejection of the quotation.
