The Project Management Unit (PMU) Khyber Pass Economic Corridor Project invites sealed quotations from eligible interested firms for the supply of items as per specifications & quantity attached.

The Following is the qualification criteria/ terms and conditions:

The offeror must be an agent/dealer or reseller of required item in Pakistan, with a minimum of Three (3) years of post-experience registration in supplies.
Supplier/dealer should have a documented track of completing at least three (5) similar assignments, involving the supply of a comparable scale. Documentary proof to be provided.
Offeror must provide the quality assurance certificate, and performance satisfactory certificates from last supplies made.
The offeror must be income Tax and Sales Tax registered and must be on active tax payer list of FBR prior to issuance of purchase order.
One-year warranty should be provided.
Quotation must be signed and stamped and typewritten.
Equipments must be delivered in Peshawar at the UPPU below within 30 days of issuance of Purchase Order/Notification of Award.
Prices shall be fixed and bid price should be in Pak Rupees.

After sales service will be required

Used , refurbished and below specification's items will not be acceptable

Project Director is the competent authority for grievance redressal.

Non-compliance of the criteria will result in rejection of the quotation.

Offeror can quote for one or more item (s) contract award will be done accordingly. Interested eligible bidders may obtain further information from Project Management Unit Khyber Pass Economic Corridor Project Ph.091-9216005

Process will be conducted through shopping mode as specified in World Bank's Procurement Regulations July 2016, revised November 2017, August 2018, and November 2020, applicable to IPF and is open to all eligible bidders as defined in the Procurement regulations.

The bidders are requested to give their best and final prices including all applicable taxes as no negotiations will be allowed at later stage. Late, conditional and incomplete quotations will not be acceptable.

The Bidder must not be blacklisted by any Government/ Semi Govt. Organization in Pakistan and no litigation is under way by any organization.

The last date of bid submission is 22<sup>th</sup> December 2022 at 2 p.m. The bidders are requested to give their best and final prices including all applicable taxes as no negotiations will be allowed at later stage. Incomplete and late bids will not be entertained.
